Task Order 01

THIS TASK ORDER IS ISSUED PURSUANT TO THE AGREEMENT FOR CONSULTING SERVICES DATED SEPTEMBER 28, 2022 FOR THE BOARD OF COUNTY COMMISSIONERS OF OKALOOSA COUNTY, FLORIDA (COUNTY), WHICH IS INCORPORATED HEREIN BY THIS REFERENCE, WITH RESPECT TO:

Professional Engineering Services for Future Water Supply Planning and General Assistance for FY2023

Article A. Purpose:

The purpose of this Task Order is to authorize and direct Jacobs Engineering Group Inc. (CONSULTANT) to provide Professional Engineering services for future water supply planning and other general assistance for FY 2023 for Okaloosa County, Florida (COUNTY). These services will be provided as directed by the COUNTY on an as-needed basis, per the request of the COUNTY. The activities that are included are described in "Article B. Scope of Work."

Article B. Scope of Services

Task 1–Technical Consultation and Support

CONSULTANT will, as requested by the COUNTY, provide ongoing technical support, expertise and consulting services related to water supply planning and other miscellaneous services as requested by the COUNTY staff. These services shall include, but not be limited to, the following items

- Assist with researching, study, planning, and evaluating water supply alternatives, existing potable water production and distribution system, and potable and non-potable water supply needs.
- Provide assistance and coordination with and report preparation for regulatory agencies such as FDEP, NWFWM, USACE to explore funding alternatives, discuss and evaluate existing, pending and future regulation, representation of County at meetings and workshops, and other services to assist the County maintain compliance with regulatory related items.
- Assist with stakeholder involvement in water supply planning related activities including local, state, and governmental stakeholders including current and potential water customers.
- Provide general professional engineering, consulting and support services as directed by COUNTY.

Article C. Compensation Provisions:

As compensation for providing the services described in this Task Order 01, the COUNTY shall pay the CONSULTANT in accordance with Section 7 – Amount and Method of Payment of the Agreement. Compensation for services for this Task Order will be on a time-and-materials basis, according to Exhibit A of the Agreement as amended with a not-to-exceed amount of \$20,000.

The CONSULTANT will keep the COUNTY informed of progress so that the budget and/or work effort can be adjusted if found necessary.

The time-and-materials sum is based on immediate authorization to proceed.

Article D. Period of Service

- Authorization to Proceed – October 1, 2022
- Termination – September 30, 2023

Article E. Authorized Representatives:
