AMENDMENT NUMBER 5**

This Amendment Number 5 is made on 4/26/2023 and amends Agreement Number 21-DHS-EP-2 ("Main Agreement") dated July 15, 2020 between Bridges to Independence, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- 3. REMOVE EXHIBIT I CONTRACTOR COVID-19 VACCINATION QUARTERLY COMPLIANCE CERTIFICATION.**
- 4. PURSUANT TO PROVISION 4: CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FOR THE THIRD SUBSEQUENT CONTRACT TERM FROM JULY 1, 2023 TO JUNE 30, 2024.**


All other terms and conditions of the Main Agreement remain in effect.
