**AMENDMENT NUMBER 4  
ASSIGNMENT OF AGREEMENT**

This **Amendment Number 4** (“Amendment”) is made on the date of execution by the County and amends Agreement Number **16-214-R** (“Main Agreement”) between **AT&T Corp.** (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor agree to amend the Main Agreement as follows:

3. **CHANGE THE CONTRACTOR ADDRESS FROM 5565 GLENRIDGE CONNECTOR ATLANTA, GA 30342 TO PO BOX 6463 CAROL STREAM, IL 60197 IN ALL INSTANCES**
4. **PARAGRAPH 1. CONTRACT DOCUMENTS IS REPLACED WITH THE FOLLOWING:**

**1. CONTRACT DOCUMENTS**

The Contract Documents consist of this Agreement and Exhibit A: Fairfax County Contract No. 4400011956 (formerly 4400006674) together with any exhibits and amendments issued or applicable thereto (collectively, “Contract Documents” or “Contract”). This Agreement rides a contract awarded to the Contractor by Fairfax County and extended by the Contractor to the County on the same terms and conditions as the Contractor’s agreement with Fairfax County. Where the terms of this Agreement vary from the terms and conditions of the other Contract Documents, the terms and conditions of this Agreement shall prevail.

The Contract Documents set forth the entire agreement between the County and the Contractor. The County and the Contractor agree that no representative or agent of either of them has made any representation or promise with respect to the parties’ agreement which is not contained in the Contract Documents.






