Memorandum of Understanding

Eglin Outdoor Recreation Department - Eglin Beach Park Lifeguard Division

This Memorandum of Understanding, entered into between the Okaloosa County Department of Public Safety and the Eglin Outdoor Recreation Department.

Witnesseth

Whereas, it is in the best interest of all parties to assist in the protection of the beach patrons from dangers that the Gulf of Mexico can pose; and

Now, Therefore be it Resolved, the Okaloosa Department of Public Safety, and the Eglin Outdoor Recreation Department mutually agree to the following:

- A. The Eglin Outdoor Recreation Department operates the Eglin Beach Park Lifeguard Division and Okaloosa County operates the Department of Public Safety Beach Safety Division on Okaloosa Island.
- B. The Eglin Beach Park Lifeguard Division will provide lifeguards to Eglin Beach Park on Okaloosa Island.
- C. The Eglin Outdoor Recreation Department, as much as possible, will employ for their Eglin Beach Park, individuals who have passed the United States Life Saving Association Open Water Rescue Training and have a minimum of forty (40) hours First Responder medical qualifications.
- D. Each organization, upon request and when able, will respond to assist each organization during emergency calls.
- E. Equipment, if available, may be loaned from one organization to another.
- F. Eglin Beach Park Lifeguard Division will follow established Okaloosa County communication protocols when communicating with the Okaloosa Beach Safety Division's Main Tower or Okaloosa 911/Communications via UHF radio on Med 5 T/A or Med 9 South (Primary) respectively.
- G. The Okaloosa County Beach Safety Division will provide a United States Life Saving Association instructor and provide training for Eglin Outdoor Recreation Department employees at no cost.
- H. The Eglin Beach Park Lifeguard Division will consult with Okaloosa County Public Safety on beach warning flag colors and have an understanding that double red flags can only be ordered by the Okaloosa County Public Safety Director or the Okaloosa County

Sheriff or their designees. For purposes of this agreement, the county Public Safety Director, the Destin Fire Control District, and the Sheriff or their designees shall jointly confer before posting double red flags.

- I. Okaloosa County Public Safety, the Destin Fire Control District, Eglin Outdoor Recreation, and a designee of the Sheriff's Office will meet quarterly to discuss areas of concern and ways to improve beach safety for all of Okaloosa County.
- J. If either party becomes unable to fulfill its obligations under this MOA or elects not to fulfill them, this MOA automatically terminates and the terminating party will be responsible for making the other party whole.

In Witness whereof, the parties hereto have caused this Memorandum of Understanding to be executed by their appropriate officials, and shall become effective upon the adoption by signature of all parties listed.
