A RESOLUTION ACCEPTING THE BID OF ELC INDUSTRIES LLC FOR LANDSCAPE MAINTENANCE SERVICES FOR THE FIRE AND POLICE DEPARTMENTS IN THE AMOUNT NOT TO EXCEED \$48,072 ANNUALLY FOR A PERIOD OF THREE YEARS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids for Landscape Maintenance services for the Fire and Police Departments were duly called for and advertised; and

WHEREAS, all bids received were opened on October 24, 2013, and are listed on the schedule attached hereto and made a part hereof; and

WHEREAS, the Deputy City Manager/Operations recommends that the bid submitted by Pure Green be rejected as non-responsive, because it did not meet bid specifications; and

WHEREAS, the Deputy City Manager/Operations recommends that the bid submitted by Ashleigh Environmental be rejected as non-responsible, due to unsatisfactory performance on an existing City contract; and

WHEREAS, the Deputy City Manager/Operations recommends acceptance of the bid submitted by ELC Industries LLC in the amount of \$48,072 as the lowest responsive and responsible bid; and

WHEREAS, the City Manager has approved the expenditure herein provided and recommends the acceptance of the bid submitted by ELC Industries LLC; and

WHEREAS, the Chief Financial Officer has filed a Sufficiency of Funds Certificate for the current fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bid submitted by a responsible and responsive bidder is the following:
