AMENDMENT NUMBER 1

This Amendment Number 1 ("Amendment") is made on the date of execution of the Amendment by the County, and amends Agreement Number 16-345-RFP ("Main Agreement") dated October 31, 2016 between Motivate International, Inc., 220 36th St, Suite 3A, Brooklyn, NY 11232 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend Main Agreement, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend Main Agreement as follows:

- I. A NEW SECTION EE IS ADDED TO ATTACHMENT A "SCOPE OF SERVICES" WITH THE FOLLOWING LANGUAGE:

EE. Mobile Application

The Contractor may sell the various Membership Types through its proprietary mobile application ("Mobile App"), free of charge to Members (other than the fees and taxes applicable for use of the System through other platforms) and the County (other than the Operation & Maintenance fees set forth in Exhibit B - Pricing Schedule) for use of the Mobile App. Advertising and sponsorships may not be placed on the Mobile App without the County's approval.

Notwithstanding anything to the contrary herein, the Contractor does not convey to County, nor does County obtain, any right or title to the Mobile App, which shall remain the sole intellectual property of the Contractor.
