## RESOLUTION NO. 2020-149

A RESOLUTION ACCEPTING THE BID OF ODYSSEY MANUFACTURING CO., FOR SALT (SODIUM CHLORIDE) AT BRENNAN WATER TREATMENT PLANT (WTP) FOR A ONE-YEAR TERM AT AN ESTIMATED AMOUNT OF \$136,800, WITH OPTIONS TO RENEW FOR FOUR ONE-YEAR TERMS; AUTHORIZING THE CITY MANAGER TO EXERCISE RENEWAL OPTIONS, SUBJECT TO BUDGETING AND APPROPRIATION AND RETURN OF THE BID SECURITY OF ALL UNSUCCESSFUL BIDDERS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids were duly called for and advertised for Salt (Sodium Chloride); and

WHEREAS, bid opening was on April 23, 2020, the Bid Tabulation being attached hereto and made a part hereof; and

WHEREAS, the Utilities Director recommends that the bid submitted by Morton Salt, Inc., be rejected as non-responsive, for the reasons outlined in the written Memorandum dated April 24, 2020, from the Buyer, which is incorporated herein by reference; and

WHEREAS, in accordance with § 30-82 of the Purchasing Code, the City will reject all non-responsive bids; and

WHEREAS, the Utilities Department Director recommends acceptance of the bid submitted by Odyssey Manufacturing Co., in the estimated amount of \$136,800 and the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. In accordance with Section 30-82 of the City Code, the City Commission finds that the lowest and best bid submitted by a responsive and responsible bidder is the following:
