Dear Mr. Burns:

Please consider this letter as the notice to proceed (NTP) with work at Kennedy Lakes Well, as outlined in your quote dated November 7, 2022 (attached). We expect the work performed to not exceed the price quoted in that correspondence. Your total estimate is \$91,858.86 for the scope of work described. Work is per the specifications and terms of the above-mentioned contract. To clarify, this work is above and beyond the work issued in the first NTP, dated 10/21/2022, and the second NTP, dated 10/31/2022.

Please note that any work that may be charged in excess of your estimate will require prior written approval from OCWS. When this work is invoiced, please make sure to include proper backup for the materials (showing documentation of the cost, plus 25% markup). Also, we understand that Line Item #10 will be billed less than the \$36,241.44 amount if physical cleaning and post-cleaning video end up not occurring.

The County has the right to inspect all work. When the old pump is being inspected at the shop, please contact Water Operations Supervisor Chris Pelfrey at 850-978-1674, so a determination can be made if it is at end-of-life or if it can be re-used at another well in the future.
