

**ARLINGTON COUNTY, VIRGINIA  
AGREEMENT NO. 21-DPR-SLA-679  
AMENDMENT NUMBER 1**

This Amendment Number 1 is made on 4/14/2023 and amends Agreement Number 21-DPR-SLA-679 ("Main Agreement") dated September 16, 2021 between RecTrac, LLC dba Vermont Systems ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. **Contract Renewal:** Pursuant to clause 4. Contract Term (amended below), this contract is hereby renewed for one additional 12-month period from July 1, 2023 to June 30, 2024 (Second Subsequent Contract Term) with two (2) additional 12-month periods remaining.
2. **Price Adjustment:** Pursuant to clause 6. Contract Price Adjustment, the Contract Amount/unit price(s) is hereby increased not to exceed the cost of living and technology ("COLT") enhancement of 4.7917255512% of the current fees.
3. **Contract Term** is hereby changed to read:

**4.CONTRACT TERM**

The Initial Term commenced on September 16, 2021 and will end no later than June 30, 2023 (Initial Contract Term), subject to any modifications provided in the Contract Documents. Upon satisfactory performance by the Contractor the County may, through issuance of a bilateral Notice of Renewal, authorize continuation of the Agreement for not more than three (3) additional 12-month periods, from July 1, 2023 to June 30, 2026 (each a "Subsequent Contract Term"). The Initial Contract Term and any Subsequent Contract Term(s) are together the "Contract Term".

4. **Exhibit B, Contract Pricing** is hereby deleted in its entirety and replaced with the attached **Revised Exhibit B, Contract Pricing** to align with the yearly maintenance and quarterly hosting beginning July 1 of each year.

All other terms and conditions of the Main Agreement remain in effect.
