This Amendment Number 2 is made on the date of execution by the County and amends Agreement Number 201-11-4 dated October 1, 2017, ("Main Agreement") between JDL Ventures, Inc. d/b/a Jeffrey's Catering Company, 4415 Wheeler Avenue, Alexandria, VA 22304 ("Contractor") and the County Board of Arlington County, Virginia ("County").
