AMENDMENT NUMBER 4

This Amendment Number 4 (“Amendment”) is made on the date of execution of the Amendment by the County and amends Invitation to Bid Number 16-342-ITB-LW, dated July 7, 2016 (“Main Agreement”) made between SimplexGrinnell, 22712 Commerce Center Court, Suite 114, Dulles, VA 20166 (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

Simplex Grinnell Fire Protection services shall be provided at the additional Arlington County Facilities listed below.
