Agreement") dated September 4, 2015	between Americ	can Disposal Services, Inc. ("Contractor") and the
County Board of Arlington County, Virgin	nia ("County").	

The County and the Contractor agree to amend the Main Agreement as follows:

- I. Renew the Contract for the first Subsequent Contract Term from July 1, 2023 to June 30, 2024 in accordance with Contract clause 3, Contract Term.
- II. In accordance with Contract clause 5, Contract Extension with Price Adjustments

 Negotiated up to CPI-U, and section 5.2 of Exhibit A increase the Contract rates for the

 first Subsequent Contract Term as follows:
 - Trash Collection \$7.65/household/month
 - Recycling Collection \$5.34/household/month
 - Organics Collection \$4.81/household/month
 - All other pricing and services under the contract will remain unchanged
- III. For the second Subsequent Contract Term (July 1, 2024 June 30, 2025), contract rates may be adjusted by the full amount of CPI-U. The CPI-U used shall be the percentage of movement of the U.S. Department of Labor, Consumer Price Index, All Items, Unadjusted, and Urban Areas for the 12-month period ending in March of 2024.
- IV. Arlington County, at its sole discretion, may terminate the exercise of the second Subsequent Contract Term, without penalty or any further obligation, provided that Arlington provides ADS with written notice of such termination at least six (6) months prior to the expiration of the first Subsequent Contract Term.
