

RESOLUTION NO. 17-339

A RESOLUTION RATIFYING THE CITY MANAGER'S EXECUTION OF AN AMENDMENT TO PROFESSIONAL SERVICES CONTRACT NO. 0113-2250, RELATING TO SAFETY INSPECTIONS AND TRAINING SERVICES, ASSIGNING THE CONTRACT FROM ALPHA-OMEGA TRAINING AND COMPLIANCE, INC., TO SALVATION SAFETY, LLC, AND REDUCING THE DAILY SERVICE FEE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, by Resolution No. 13-256, the City Commission approved Professional Services Contract No. 0113-2250 with Alpha-Omega Training and Compliance, Inc. ("Alpha-Omega"), for provision of as-needed City facility safety inspections and City employee safety training, for a one-year Term ending September 30, 2014, with options to renew for four additional one-year Terms; and

WHEREAS, as authorized in the Resolution, the City Manager previously exercised all of the options to renew provided in the Contract, and the Contract is scheduled to expire on September 30, 2018; and

WHEREAS, Alpha-Omega Endeavors, LLC, the parent company to Alpha-Omega, has assigned all of Alpha-Omega's safety operations to Salvation Safety, LLC; and

WHEREAS, in order to obtain the City's consent to the assignment of the Contract, Alpha-Omega Endeavors, LLC, offered to reduce the daily rate for services under the Contract from \$1,492 to \$1,460, so long as an agreement was reached prior to October 1, 2017; and

WHEREAS, a contract amendment, authorizing the assignment and rate decrease, and including new public records provisions required by Florida law, was executed on the City's behalf; and


WHEREAS, the Risk Manager recommends that the City Commission ratify the City Manager's execution of the contract amendment; and

WHEREAS, the Chief Financial Officer has submitted a Sufficiency of Funds Certificate in the amount of \$50,000 for the estimated cost of service during Fiscal Year 2017-2018.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission hereby ratifies the City Manager's execution of the Assignment and Amendment to Professional Services Contract No. 0113-2250 with Alpha-Omega Training and Compliance, Inc., and Salvation Safety, LLC, for as-needed City facility safety inspection and City employee safety training, assigning the Contract to Salvation Safety, LLC, and including the additional changes referenced in the recitals.

SECTION 2. This Resolution shall take effect immediately upon its adoption.
