Wherever practicable, such records should be collected, transmitted, and stored in open and machine-readable formats. Your company must agree to provide or make available such records to Treasury upon request, and to the Government Accountability Office ("GAO"), Treasury's Office of Inspector General ("OIG"), and their authorized representative in order to conduct audits or other investigations and retain these records in compliance with the OMB guidance 2 C.F.R. §200.333.

#### Task Orders

All task orders involving the American Rescue Plan Act, CoronavirusState and Local Fiscal Recovery Fund, shall comply with the County's grant agreement with the U.S. Treasury, grant agreement no. SLT-0786, terms and conditions, to the extent applicable. The vendor/consultant acknowledges that is has been provided with a copy of the grant agreement in order to understand the specific requirements of the grant.

- 2. OTHER PROVISIONS REMAIN IN EFFECT. Except as specifically modified herein, all terms and conditions of the original Agreement and any amendments thereto, shall remain in full force and effect.
- CONFLICTING PROVISIONS. The terms, statements, requirements, or provisions
  contained in this Amendment shall prevail and be given superior effect and priority over any
  conflicting or inconsistent terms, statements, requirements or provisions contained in any other
  document or attachment.
