AGREEMENT NO. 20-725-EP AMENDMENT NUMBER 1

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 20-725-EP ("Main Agreement") dated 10/9/2020 between Creative Empire LLC, d/b/a Mango Languages ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

REPLACE EXHIBIT A – TERMS OF SERVICE, PARAGRAPH 2 - FEES WITH THE FOLLOWING LANGUAGE:

The County shall pay Mango \$15,474.50 for the Services during the Initial Contract Term (the "Initial Payment Amount"). Prior to the commencement of each Successor Term(s), County and Mango shall agree upon the amount County shall pay Mango for the upcoming Subsequent Contract Term (the "Successor Payment Amount").

In the event that Mango fails to provide such service for five days within a 30-day period, Mango shall provide a pro rata refund for the 30 day period in question.
