**AGREEMENT NO. 17-038-ITB-LW  
AMENDMENT 1**

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 17-038-ITB-LW dated December 15, 2016, ("Main Agreement") between EnviroSolutions, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

WHEREAS, EnviroSolutions, Inc. and the County entered into the Main Agreement for EnviroSolutions, Inc. to provide Refuse and recycling collection services for County Facilities; and

WHEREAS, EnviroSolutions, Inc. has transferred all the terms, conditions, and Scope of Work as contained in the Contract to Waste Management of Virginia, Inc pursuant to the merger of EnviroSolutions, Inc. and Waste Management of Virginia, Inc

and

WHEREAS, Waste Management of Virginia, Inc has assumed all obligations and liabilities of EnviroSolutions, Inc under this Contract by virtue of the above merger; and

WHEREAS, the County consents to the assignment of this Contract to Waste Management of Virginia, Inc beginning on January 1, 2019 ("Effective Date"); and

WHEREAS, in consideration of the promises and other good and valuable consideration specified in this Amendment, Main Agreement, is amended as follows:

1. In place of EnviroSolutions, Inc. the County agrees that Waste Management of Virginia, Inc shall be the contracting party, and Waste Management of Virginia, Inc shall provide the services under the Agreement;
2. Waste Management of Virginia, Inc agrees to be bound by and to perform this Contract in accordance with the conditions contained in the Contract Documents; and
3. The term "Contractor" in the Contract shall hereinafter Waste Management of Virginia, Inc
