**AGREEMENT NO. 21-DHS-RFP-598a
AMENDMENT NUMBER 2**

This Amendment Number 2 is made on the date of execution by the County and amends Agreement Number 21-DHS-RFP-598a ("Main Agreement") dated December 1, 2021, between Best Buddies International, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").


The County and the Contractor agree to amend the Main Agreement as follows:

- 1. REVISE CONTRACT NO. FROM 21-DHS-EP-598a TO READ 21-DHS-RFP-598a.**
- 2. PURSUANT TO CLAUSE 4. CONTRACT TERM, THIS AGREEMENT IS HEREBY RENEWED FROM DECEMBER 1, 2023 TO NOVEMBER 30, 2024.**
- 3. PURSUANT TO CLAUSE 6. CONTRACT PRICE ADJUSTMENTS, THE CONTRACT PRICE IS HERBY INCREASED BY 3.7% FOR THE 12 MONTH PERIOD ENDING NOVEMBER 30, 2024.**
- 4. REPLACE EXHIBIT B. CONTRACT PRICING IN ITS ENTIRITY WITH THE ATTACHED.**
- 5. REMOVE CLAUSE 54 COVID-19 VACCINATION POLICY FOR CONTRACTORS IN ITS ENTIRETY.**
- 6. REMOVE EXHIBIT D CONTRACTOR COVID-19 VACCINATION CERTIFICATION.**
- 7. REMOVE EXHIBIT E CONTRACTOR COVID-19 VACCINATION QUARTERLY COMPLIANCE CERTIFICATION.**

All other terms and conditions of the Main Agreement remain in effect.
