Request for Time Extension

Mr. Joseph,

Highway and Safety Services is respectfully asking for consideration for a time extension for Madison Manor Park.

Arlington County specified Themed Concepts as the manufacturer of the major pieces for playground equipment for the above referenced project.

Highway and Safety Services (HSS) subcontracted Playground Specialists (PS) - the local distributor of **Themed Concepts,** on September 10th, 2019. From September 9th, 2019 to September 13th, 2019, PS provided submittals for the equipment specified in the plans and specs. These submittals were entered into Submittal Exchange.

On October 15th, 2019, PS contacted HSS and asked to have **Cre8Play** submitted as an alternate supply of the playground equipment because Themed Concepts was unable to provide the equipment specified.

On October 15th, 2019, HSS asked the County if this substitution could be made based on:

- 1. Arlington County will agree to the change
- 2. Pricing will not increase
- 3. Lead time remains the same
- 4. Submittals must be approved by Arlington County

Arlington County agreed to the change based on the above, on October 15th, 2019.

Due to the change in manufacturers, there is a possibility that the playground equipment cannot be manufactured as per our schedule.

HSS agreed to work with PS to minimize the impact on the schedule by scheduling the footer/pads to be installed early as possible and to move the construction entrance so that other work can continue.

After the playground equipment is installed, several additional items need to be completed: Rubber mulch – 8 Working Days

Fencing - 3 Working Days

Curbing - 4 Working Days

Construction entrance removed and any restorations that may be required – 4 Working Days Removal of E&S - 2 Working Days

This amounts to a minimum of 21 days of work to be completed after the playground equipment is installed. If the playground equipment can be installed (as per the letter from PS), on March 19, 2019, this would place us at April 17^{th} , 2019.

Attached are letters/emails from the manufacturer of the playground equipment, the supplier for the playground equipment and the rubber mulch subcontractor time lines. Until the construction entrance is moved it is not known how much fencing will still need to be installed. We will not know how much time it will take to remove the new construction entrance and repair any residual damage that it might entail.

HSS fully intends to have all other work completed prior to the installation of the playground equipment. We also ask for the punch list (excluding the playground equipment) to be prepared early in March.
