## AGREEMENT NO. 19-071-1-RFP-LW AMENDMENT NUMBER 8

This Amendment Number 8 is made on January 3, 2022 and amends Agreement Number 19-071-1-RFP-LW, ("Main Agreement") dated December 5, 2019 between Arlington Street People's Assistance Network, Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

## I. ADD THE FOLLOWING TO REVISED EXHIBIT A, SCOPE OF SERVICES, SECTION 1, GENERAL REQUIREMENTS:

J. Due to high rates of COVID-19 transmission, the Contractor must temporarily provide non-congregate sheltering. Beginning on or after January 3, 2022 and until February 28, 2022, the Contractor must relocate all shelter guests from the Homeless Services Center, Hypothermia Shelter, and the Medical Respite Program to the Days Inn Pentagon located at 3030 Columbia Pike, Arlington VA 22204.

The County may extend the non-congregate sheltering program on a monthly basis by providing written notice to the Contractor no later than the 15th of each proceeding month.

During the non-congregate sheltering period, the Contractor must follow Hotel Operations for Non-Congregate Sheltering Standard Operating Procedures (SOPs) located here: <a href="https://www.arlingtonva.us/Government/Departments/DHS/Public-Assistance/Action-Plan-Homelessness/Continuum-Care">https://www.arlingtonva.us/Government/Departments/DHS/Public-Assistance/Action-Plan-Homelessness/Continuum-Care</a>, in addition to the County's Unified Shelter Standard Operating Procedures and the Continuum of Care (CoC) COVID-19 Guidance for Emergency Shelters. This includes ensuring 24-7 staff coverage, case management to Contractor's clients, and on-call support from management.

Due to the unpredictable nature of the COVID-19 pandemic, the Hotel Operations for Non-Congregate Sheltering SOPs may be updated, in which case the County will notify the Contractor in writing to review the updated document.

The Contractor must continue to provide all services outlined in Revised Exhibit A: Scope of Services, with the exception of providing meals and clean linens for shelter guests and operating the Day Program. The Contractor must continue to provide bagged lunches for persons experiencing unsheltered homelessness in conjunction with the Outreach Program and must assist in the distribution of County-purchased meals at the non-congregate shelter site.

All other terms and conditions of the Main Agreement, as amended shall remain in full force and effect.
