AGREEMENT NO. 16-190-ITB
AMENDMENT NUMBER 1

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 16-190-ITB ("Main Agreement") dated March 15, 2016 between DSI, Inc., 1701 Ridgely Street, Baltimore, MD 21230 ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

REVISE THE CONTRACT TERM TO READ AS FOLLOWS:

4. CONTRACT TERM

The Work shall commence on the date of the execution of the Agreement by the County, and shall be completed no later than March 31, 2017 ("Initial Contract Term"), subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may, through issuance of an amendment executed by the parties, authorize continued operations of the Contractor under the same contract prices for not more than four (4) additional twelve (12) month periods from April 1, 2017 to March 31, 2021 (each such period shall be referred to as "Subsequent Contract Term").

Additionally:

The Contract Term is hereby renewed for the period beginning April 1, 2020 and expires March 31, 2021.

All other terms and conditions of the Main Agreement remain in effect.
