AGREEMENT NO. 21-DES-ITB-228**

**AMENDMENT NUMBER 1
ASSIGNMENT OF AGREEMENT**

This Amendment Number 1 (“Amendment”) is made on the date of execution by the County and amends Agreement Number 21-DES-ITB-228 (“Main Agreement”) between Parts Authority Southern, LLC, 9731 Washington Blvd. N, Laurel, MD 20723 (“Contractor”), and the County Board of Arlington County, Virginia (“County”).

Parts Authority Southern, LLC, and the County entered into the Main Agreement for Parts Authority Southern, LLC to provide batteries for repairs on automobiles, light and heavy trucks and related equipment on an as-needed basis.

Parts Authority, LLC has assumed all of Parts Authority Southern, LLC rights and obligations in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Parts Authority, LLC beginning on October 26, 2021 (“Effective Date”).

The Main Agreement is therefore amended as follows:

1. Parts Authority Southern, LLC is in all instances replaced with Parts Authority, LLC;
2. The term “Contractor” in the Main Agreement means Parts Authority, LLC;

4. Section 4., **CONTRACT TERM**, is hereby renewed for the contract period of October 21, 2021 through October 20, 2022.

5. Section 52., **COVID-19 Vaccination Policy For Contractors is hereby added:**

COVID-19 VACCINATION POLICY FOR CONTRACTORS

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County's workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, must be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor, unless exempt pursuant to a valid reasonable accommodation under state or federal law.

All other terms and conditions of the Main Agreement remain in full force and effect.
