AMENDMENT NUMBER 2**

This Amendment Number 2 is made on June 9, 2020 and amends Agreement Number 20-140-ITBLW dated January 22, 2020, ("Main Agreement") between 1st Lady Janitorial Services, LLC ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Scope of Work called for under the Main Agreement as follows:

1. The County anticipates reopening the parks around June 24, 2020 and is hereby reinstating custodial services for all park locations. Within seven (7) days of the parks reopening, the County will notify the Contractor of the County's intent to reinstate custodial services at these locations.
