AMENDMENT NO. 4

This Amendment Number 4 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number **16-069-9-X** dated December 14th 2015 ("Main Agreement") and as amended by Amendment 1 and 3, between **Dr. Ana San Martin**, 10241 Farnham Drive, Bethesda, MD 20814 ("Contractor"), licensed to practice medicine in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the Contract Term, Contract Amount, and Contract Number called for under the Main Agreement as follows:

3. CONTRACT TERM, SHALL BE REVISED AS FOLLOWS:

Work under this Agreement will continue from **October 1, 2019 to September 30, 2020** in accordance with this Agreement; subject to any modifications as provided for in the Contract Documents. This will be the fifth of five (5) Subsequent Contract Terms.

4. CONTRACT AMOUNT, SHALL BE REVISED AS FOLLOWS:

October 1, 2018 to September 30, 2019 Funding:

The County will increase the contract amount by \$61,700 to \$138,780 for the completion of the work described and required in the Contract Documents. The Contract Amount and hourly rate for each Subsequent Contract Term shall be in the amount mutually agreed upon but which will in no event exceed the funds appropriated for the services.

October 1, 2019 to September 30, 2020 Funding:

The County will pay to the Contractor, according to the terms of the "Payment" paragraph below and the Exhibit A, no more than **\$ 138,780** for the Contract Term (October 1, 2019 – September 30, 2020) for the completion of the work described and required in the Contract Documents, subject to the terms and conditions in those documents.

REVISE CONTRACT NUMBER

The Contract Number is hereby changed to 16-069-9-EP to identify the Contract as an Exempt Purchase Agreement EP30: Goods and personal services for direct use by individual recipients of public assistance program as defined in section 37.1-1 of the Code of Virginia


All other terms and conditions of the Main Agreement remain in effect.
