AMENDMENT NUMBER 12**

This Amendment Number 12 is made on May 28, 2020 by the County and amends Agreement Number 623-12 ("Main Agreement") dated April 2, 2012 between Professional Pest Solutions, LLC ("Contractor") and the County Board of Arlington County, Virginia ("County").
