#### ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 18-058-SS AMENDMENT NUMBER 1

This **Amendment Number 1** ("Amendment") is made on the date of execution of the Amendment by the County and amends **Agreement Number 18-058-SS** dated **June 26, 2018** ("Main Agreement"), made between **Northern Virginia Juvenile Detention Center, dba Sheltercare of Northern Virginia, 5920 Stevenson Avenue, Alexandria, VA 22304** ("Contractor"), and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the contract terms and conditions and scope of work called for under the Main Agreement as follows:

#### 1. AMEND SECTION 5. CONTRACT AMOUNT TO HEREBY READ AS FOLLOWS:

The vendor may update pricing annually. The County will not compensate the Contractor for any goods or services beyond those included in Attachment A unless those additional goods or services are covered by a fully executed amendment to this Contract.
