ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 18-031-EP AMENDMENT NUMBER 3

This **Amendment Number 3** ("Amendment") is made on $\frac{6/15/2023}{}$ and amends **Agreement Number 18-031-EP** dated **September 8, 2017** ("Main Agreement") and made between <u>St. John's Community Services, 7611 Little River Turnpike Suite 404, Annandale, VA 22003</u> ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

- Contract Renewal: Pursuant to Clause 4. Contract Term, this agreement is hereby renewed for its second 12-month period, from July 1, 2023 to June 30, 2024 with three (3) additional 12month periods remaining.
- 2. EXHIBIT B, CONTRACT PRICING is replaced in its entirety with the attached Revised Exhibit B, Contract Pricing to increase the in-home support services rate from \$29.84 per hour to \$43.27 per hour for fiscal year 2023 and provide the increased rates for fiscal year 2024.

All other terms and conditions of the Main Agreement, as amended, shall remain in full force and effect.

EXHBIT B - REVISED CONTRACT PRICING

For Fiscal Year 2023

Non-Medicaid Waiver Eligible clients will be billed to Arlington County DD Services at the current DMAS in-home support services rate: \$43.27 per hour, up to a maximum of \$107,000.00, an increase of \$28,000.00, effective immediately through June 30, 2023.

For Fiscal Year 2024

The Contractor shall bill Medicaid through Department of Medical Assistance (DMAS) for services provided to Arlington individuals with DD Medicaid Waiver. Additionally, the County agrees to pay the Contractor up to the maximum amount of \$159,000.00 per year for in-home support services delivered to Arlington County clients.

Non-Medicaid Waiver Eligible clients will be billed to Arlington County DD Services at the current DMAS in-home support services rate: \$43.27 per hour, up to a maximum of \$150,000.00, effective July 1, 2023.

If needed, additional DMAS in-home support rates can also be applied: \$24.63 per hour/per person for services from one staff supporting 2 individuals at the same time or \$17.75 per hour/per person for services from one staff supporting 3 individuals at the same time.

The Contractor may bill Arlington County DD Services for indirect services not paid by DMAS for locally funded and DD Waiver eligible clients. These include staff travel time (reimbursed at the GSA's mileage rates current at the time of travel) and report writing, at the rate of \$36 per hour, up to a maximum of 250 hours per contract term, maximum of \$9,000.00. Staff travel log must include staff name, starting address, ending address and total miles per trip.

Arlington County funds must be used in adherence to all Federal and Commonwealth of Virginia, Department of Medical Assistance Services regulations governing DD Home and Community-Based Medicaid Waiver Services.
