Whereas the County and the Contractor desire to amend the Scope of Work, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement, as follows.

- o Remove the following location from the scope of work: LS-46 1727 N Fairfax Drive effective May 2017.
- o Reduce the contract cost by \$375/Mo, or \$4,500.00 per year.

All other terms and conditions of the Main Agreement and Exhibits, as amended shall remain in full force and effect.


