**Unilateral Amendment**  
**AGREEMENT NO. 22-DES-R-677**  
**AMENDMENT NUMBER 2**

This Amendment Number **2** is made on 11/2/2022 by the County and amends Agreement Number **22-DES-R-677** ("Main Agreement") dated **April 1, 2022**, between **Eastern Waterproofing & Restoration of Virginia LLC** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

1. Contract Term is hereby deleted in its entirety and **replaced** with:



**2. CONTRACT TERM**

The Contractor's provision of goods and services for the County ("Work") shall commence upon the execution of the Agreement by the County" and shall be completed no later than January 19th, 2027 ("Contract Term"), subject to any modifications as provided for in the Contract Documents regarding the Contract Term. No aspect of the Work shall be deemed complete until it is accepted by the County's Project Officer. Upon satisfactory performance by the Contractor, if the County of Fairfax, Virginia renews their agreement identified in Exhibit A, the County may elect to renew this Agreement under the same contract terms for 3 (1) one-year renewal periods from **January 20, 2023**, to **January 19th, 2024** ("Subsequent Contract Term"). However, if the County of Fairfax, Virginia does NOT renew their agreement identified in Exhibit A, this Agreement shall automatically expire on the contract expiration date.

All other terms and conditions of the Main Agreement remain in effect.
