AGREEMENT NO. 603-13-2**

AMENDMENT NUMBER 10

This **Amendment Number 10** ("Amendment") is made on the date of execution by the County and amends Agreement No. 603-13-2 dated April 15, 2014 made between **Diamond Transportation Services, Inc.** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the Main Agreement as follows:

- 1. PURSUANT TO PROVISION 3. CONTRACT TERM, THE COUNTY EXERCISES THE 5TH OF FIVE (5) ONE-YEAR OPTION EXTENSIONS FOR THE PERIOD OF JUNE 1, 2023 TO MAY 31, 2024.**
- 2. PURSUANT TO PROVISION 6. CONTRACT EXTENSION WITH NEGOTIATED PRICE ADJUSTMENTS FOR STAR/SAP SERVICES' DEDICATED VEHICLES AND IDDS SERVICES' FIXED ROUTES, THE FY24 PRICING FOR THE STAR/SAP SERVICES AND IDDS ROUTES SHALL BE AS INDICATED ON ATTACHMENT 1 (ATTACHED).**




