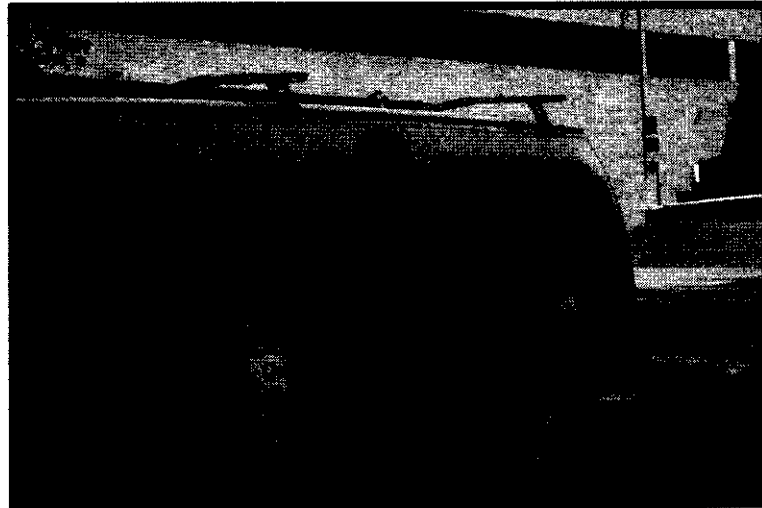

- Lock out and tag out each unit per the Daikin safety protocol.
- Provide and install new water fill solenoids and elbow fittings on cru 1 and cru 2.
- Provide and install new float assembly and din rail terminal strips on cru 1 and cru 2.
- Provide and install (2) additional return grilles, one for cru 1 and one for cru 2 to provide better return air flow.
- Provide and install new elbow fitting for fill solenoid on cru 3.
- Provide and install new float assembly for humidifier on cru 4.
- Return all units to service and monitor operation.
