FIRST AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA COUNTY, FLORIDA AND EMERALD COAST REGIONAL COUNCIL
CONTRACT NO. C05-1151-PW

This First Amendment to the Agreement between Okaloosa County, a political subdivision of the State of Florida (the "County"), and Emerald Coast Regional Council ("Contractor"), executed this 14th day of July, 2022, is made a part of the original Agreement dated August 27, 2010, Contract No. C05-1151-PW (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **AMENDMENT.** The County hereby agrees to extend the deadline for Contractor to transmit all completed data to the Florida Department of Environmental Protection, Bureau of Solid and Hazardous Waste from June 30th to September 30, 2022.
2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, and any amendments thereto, shall remain in full force and effect.
3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
