1. **AMENDMENT.** The County and Contractor would like to amend Section 2 of the original agreement to add the following line item:

4" Rumble Strip Set \$600.00 per set

This amendment shall be retroactively dated back to May 1, 2022.

2. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated July 20, 2021 and any amendments thereto, shall remain in full force and effect.

3. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
