AMENDMENT NUMBER 1**

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 20-814-SS ("Main Agreement") dated March 4, 2020 between DC Materials, Inc., 3334 Kenilworth Avenue, Hyattsville, Maryland 20781 ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows: DC Materials is no longer able to accept concrete and asphalt larger than 12" at the Palmer Road Landfill.

Amend EXHIBIT A

Add location 3334 Kenilworth Avenue, Hyattsville, Maryland 20781

Unit: Per Truck Load – Concrete and Asphalt cannot be larger than 2' x 2'in size and 6" thick. Asphalt must not contain fabric. Concrete must not contain rebar or excess wire. No demo trailers allowed.

Clean Concrete Cost: \$105.00

Concrete Mixed Load Cost: \$135.00

Asphalt Cost: \$305.00

All other terms and conditions of the Main Agreement remain in effect.
