

RESOLUTION NO. 2020-239

A RESOLUTION ACCEPTING THE BID OF PRIEST PROPERTY MAINTENANCE, LLC FOR LANDSCAPE MAINTENANCE AND MOWING FOR MISCELLANEOUS CITY LOTS FOR A THREE-YEAR TERM WITH THE OPTION TO RENEW UP TO 2 ONE-YEAR TERMS; APPROVING THE EXPENDITURE IN THE AMOUNT NOT TO EXCEED \$6,050, INCLUDING A ONE-TIME LUMP SUM AMOUNT OF \$1,775 FOR THE REMAINDER OF FISCAL YEAR; AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS IN THE AMOUNT OF \$32,275 PER YEAR, SUBJECT TO BUDGET AND APPROPRIATIONS; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONTRACT FOR LANDSCAPE MAINTENANCE-MISC. LOTS IN ACCORDANCE WITH THE BID DOCUMENTS AND RETURN OF THE BID SECURITY OF ALL UNSUCCESSFUL BIDDERS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids were duly called for and advertised for Landscape Maintenance  
– Misc. Lots; and

WHEREAS, bid opening was on March 26, 2020, the Bid Tabulation being attached hereto and made a part hereof; and

WHEREAS, the Public Works Director recommends acceptance of the bid submitted by Priest Property Maintenance, LLC and the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bid submitted by a responsive bidder is the following:

SECTION 3. The Mayor and City Clerk are hereby authorized to execute the Contract for Landscape Maintenance- Misc. Lots, with Priest Property Maintenance LLC, in accordance with the bid documents.


