Memorandum of Understanding

This MEMORAND	UM OF UNDERSTANDING ("MOU"), entered into this $_18$ th $__$ day of	
September	, 2018, by and between the BOARD OF COUNTY COMMISSIONERS OF	
OKALOOSA COUNTY ("the County"), whose address is 1250 North Eglin Parkway, Suite 100,		
Shalimar, FL 32579 and the OKALOOSA COUNTY CLERK OF CIRCUIT COURTS AND		
COMPTROLLER, whose address is 302 North Wilson Street, Crestview, FL 32536 ("the Clerk").		

WHEREAS, this MOU is entered into under the authority granted to the County and the Clerk; and

WHEREAS, the County and the Clerk are collectively working towards maintaining effective and efficient Courier Services within the County, which provide services to County Departments, Constitutional Offices, and the Judicial System; and

WHEREAS, the Clerk has agreed to accept the duties and responsibilities of supervising the Courier Services, which will further enhance the Clerk's movement of evidence within the Judicial System of Okaloosa County; and

WHEREAS, the Clerk has incorporated the cost of the Courier Services into his budget for fiscal year 2018-2019; and

WHEREAS, assignment of the 2016 Ford Transit 150 vehicle (VIN#
1FMZK1YM4GKB22367) which is currently being used by the County for the provision of Courier
Services will be transferred to the Clerk who will be responsible for the cost of on-going
maintenance, which shall include but not be limited to, fuel, insurance, repair and replacement
if required

NOW, THEREFORE, the County and the Clerk agree to the following:

- 1. The above recitals are true and incorporated herein as if they were set forth in their entirety.
- 2. To facilitate the transition of Courier Services from the County to the Clerk, the County and the Clerk agree to work collaboratively in defining Courier routes,

Courier scheduling, and implementing said routes and schedules. The Courier will continue to service the currently served locations and entities listed in Attachment

- 1. The Clerk and the County may modify the list of served locations and entities without the necessity of a formal amendment to this MOU. However, an updated written list of currently served locations and entities will be provided to the Clerk and the County Administrator.
- 3. The Courier position will be an employee of the Clerk.
- 4. The Clerk's oversight and management of Courier Services shall be reviewed annually during the budget process to ensure all parties are satisfied with the effective and efficient delivery of courier services.
- 5. Either the County or the Clerk may terminate this MOU with written notification at least sixty (60) days prior to termination. Upon the termination of this MOU, assignment of the above referenced vehicle or its replacement and equipment shall be transferred back to the County.
