City Contract number 0117-2010, Resolution 17-352, providing for HIGH CALCIUM BULK QUICKLIME by Carmeuse Lime & Stone hereby accepts the rate increase from \$232.50 per ton to \$244.35 per ton. This contract will not exceed \$2,000,000.00.


WHEREAS, the City issued Invitation to Bid No. 0117-2010 ("ITB"), for the supply of high calcium bulk quicklime (hereinafter "Quicklime")—for a Term of one year commencing on October 3, 2017, and ending on October 2, 2018, with the City having two one-year renewal options subject to (i) the vendor's right to submit proposed price increases for the renewal period, based solely upon increases in Vendor's costs, such as material costs, with accompanying cost data, within a 180 days prior to renewal, to take effect at the renewal date; (ii) the City's right to review the proposed increase and within 60 days of submittal of the proposed increase, approve or reject such increases, (iii) the vendor's right to opt out of the renewal within 10 days of receiving the City's rejection;

Pursuant to paragraph 2 of the Contact documents, the City of Daytona Beach hereby gives notice that it desires to renew the first of two Contract renewal options at the adjusted rate above for the term of 1 year(s) beginning October 3, 2018 and ending October 2, 2019 under the same terms and conditions, including fee structure.


