A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE CONTINUING SERVICES CONTRACTS WITH NEEL-SCHAFFER, INC., HALL ARCHITECTURAL ASSOCIATES, INC., HAWKINS & HALL ARCHITECTS, INC., BELLOMO-HERBERT & COMPANY, INC., LAND DESIGN INNOVATIONS, INC., MILLER, LEGG & ASSOCIATES, INC., STERN DESIGN GROUP, INC., F.R. ALEMAN & ASSOCIATES, INC., AND DICKENS & ASSOCIATES, INC., TO PROVIDE ASNEEDED PROFESSIONAL ENGINEEERING CONSULTANT SERVICES FOR VARIOUS PROJECTS FROM QUALIFIED DISCIPLINES; AND PROVIDING WHEN THIS RESOLUTION SHALL TAKE EFFECT.

WHEREAS, pursuant to Resolution No. 05-173, The City of Daytona Beach duly advertised for Professional Engineering Consultant Services under continuing contract to support various City projects in the areas of architectural, landscaping architecture, electric and structural engineering in order to promote continuity of engineering consultant services by having consultants that were pre-qualified under the Consultants Competitive Negotiations Act (CCNA) and Chapter 30, City Code, available on a continuous basis for various projects; and

WHEREAS, the City's selection committee recommends Neel-Schaffer, Inc., Hall Architectural Associates, Inc., Hawkins & Hall Architects, Inc., Bellomo-Herbert & Company, Inc., Land Design Innovations, Inc., Miller, Legg & Associates, Inc., Stern Design Group, Inc., F.R. Aleman & Associates, Inc., and Dickens & Associates, Inc., as its preferences for negotiating contracts; and

WHEREAS, negotiations ensued between the City and the consultants, and Contracts for Professional Services were prepared subject to the approval of the City Commission; and

WHEREAS, the City Manager and the Public Works Director recommend approval of the contracts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE

CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The Mayor and City Clerk are hereby authorized to execute continuing

services contracts for professional consulting services with Neel-Schaffer, Inc., Hall Architectural

Associates, Inc., Hawkins & Hall Architects, Inc., Bellomo-Herbert & Company, Inc., Land Design

Innovations, Inc., Miller, Legg & Associates, Inc., Stern Design Group, Inc., F.R. Aleman &

Associates, Inc., and Dickens & Associates, Inc., to provide as-needed professional engineering

consultant services to the City with the scope of services and compensation to be negotiated and

mutually agreed upon for each project prior to authorization by the City, copies of said contracts are

attached hereto and by reference made a part hereof. The authorization of these Contracts is subject

to the City Attorney's final approval as to legal form.

SECTION 2. The City Manager is instructed to solicit additional firms to replace

any of the firms approved in Section 1 above, which no longer provide services to the City.

SECTION 3. This Resolution shall take effect immediately upon its adoption.
