**SECOND AMENDMENT AND RENEWAL TO THE AGREEMENT BETWEEN**  
**OKALOOSA COUNTY, FLORIDA AND**  
**GLAZE COMMUNICATION SERVICES, INC.**  
**CONTRACT NO. C18-2658-IT**

This Second Amendment and Renewal to the Agreement between Okaloosa County, a political subdivision of the state of Florida (the "County"), and Glaze Communications Services, Inc., executed this 1<sup>st</sup> day of February, 2022, is made a part of the original Agreement dated February 1, 2018, Contract No. C18-2658-IT (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **OPTION TO RENEW.** The parties hereby wish to exercise their final option to renew the original Agreement for an additional one (1) year term in accordance with Section V of the original Agreement.
2. **EFFECTIVE DATE OF RENEWAL TERM.** The Effective Date of this Amendment shall commence February 1, 2022 and shall terminate no later than January 31, 2023.
3. **COMPENSATION.** Compensation for this renewal term of the Agreement shall:

Section III of the original Agreement ("Compensation") shall be revised as follows:

The new rate for the final term will be \$59.22 per hour.

4. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated February 1, 2018 and any amendments thereto, shall remain in full force and effect.
5. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
