**AGREEMENT NO. 507-12
AMENDMENT NUMBER 7**

This Amendment Number 7 is made on the date of execution by the County and amends Agreement Number 507-12 dated April 17, 2012, (“Main Agreement”) between **Social Solutions Global, Inc., 10801-2 North MoPac Expressway, Suite 400, Austin, Texas 78759** (“Contractor”) and the County Board of Arlington County, Virginia (“County”).

The County and the Contractor amend the Contract Term called for under the Main Agreement as follows to provide additional time to review proposed revisions of the contract terms and conditions by the Contractor:

CONTRACT TERM:

The contract shall continue from May 1, 2019 to August 31, 2019 (“Subsequent Contract Term”), subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may authorize continued operations of the Contractor for an additional three (3) twelve (12) month periods from September 1, 2019 through April 18, 2022 (“Subsequent Contract Term”).



All other terms and conditions of the Main Agreement remain in effect.
