**AGREEMENT NO. 19-287-R
AMENDMENT NUMBER 1**

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 19-287-R ("Main Agreement") dated June 27, 2019 between **Atlantic Emergency Solutions** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

1. REMOVE CLAUSE 2, CONTRACT TERM IN ITS ENTIRETY AND REPLACE WITH THE FOLLOWING:

2. CONTRACT TERM

The Contractor's provision of goods and services for the County ("Work") shall commence upon the execution of the Agreement by the County", and shall be completed no later than April 10, 2022 ("Contract Term"), subject to any modifications as provided for in the Contract Documents regarding the Contract Term. No aspect of the Work shall be deemed complete until it is accepted by the County's Project Officer.

Upon satisfactory performance by the Contractor, if the Metropolitan Washington Council of Governments (COG) renews their agreement identified in Exhibit A, the County may elect to renew this Agreement under the same contract terms for two (2) three-year renewal periods from April 11, 2022 to April 10, 2028 ("Subsequent Contract Term"). However, if the Metropolitan Washington Council of Governments (COG) does NOT renew their agreement identified in Exhibit A, this Agreement shall automatically expire on the contract expiration date.

2. PURSUANT TO CLAUSE 2, CONTRACT TERM, THE COUNTY EXTENDS THE AGREEMENT FOR THE FIRST THREE-YEAR RENEWAL OPTION FROM APRIL 11, 2022 TO APRIL 10, 2025 PER ATTACHMENT 1.

All other terms and conditions of the Main Agreement remain in effect.
