Mr. Reynolds,

Glad we had a chance to discuss our upcoming work by phone a moment ago. Here are the details for what is to be included in proposal:

- Influent Channels- There are 2 and the dimensions for channel 1 are 4'x7'20' and channel 2 is 4'x 7'x30'.
- These will more than likely need to be done in 2 trips to accommodate leaving one channel active during work. The first trough would need to be more in the near future, but the 2<sup>nd</sup> one we have some flexibility on.
- Contractor onsite will take care of dewatering, cleaning and removal of old coating. They have begun on existing coating removal and it appears that it should come off fairly cleanly from what lve been told. The spectra shield will go down before the screening equipment in the drawings is installed so your crew wont need to work around them. It will just be a bare channel
