**SECOND AMENDMENT TO THE AGREEMENT BETWEEN OKALOOSA  
COUNTY, FLORIDA AND WASTE MANAGEMENT INC. OF FLORIDA  
CONTRACT NO. C22-3159-FM**

This Second Amendment and Renewal to the Agreement between Okaloosa County, a political subdivision of the State of Florida ( "County"), and Waste Management Inc. of Florida ("Contractor"), executed this 1st day of March, 2023, is made a part of the original Agreement dated March 1, 2022, Contract No. C22-3159-FM (the "original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

1. **OPTION TO RENEW.** The parties hereby wish to exercise the option to renew the original Agreement for an additional one (1) year term commencing March 1, 2023 and ending on February 29, 2024. The agreement can be renewed for an additional three (3) years thereafter.

2. **AMENDMENT.** The parties hereby agree to amend Section 2 of the original Agreement to add the following location to receive trash collection services:

105 Santa Rosa Blvd, FWB, FL 32548

3. **COMPENSATION.** Contractor agrees to provide trash collection services at both locations pursuant to the rates included in Section 1 of the First Amendment to the original Agreement.

4. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties, dated March 1, 2022, and any amendments thereto, shall remain in full force and effect.

5. **CONFLICTING PROVISIONS.** The terms, statements, requirements, or provisions contained in this Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent terms, statements, requirements or provisions contained in any other document or attachment.
