RESOLUTION NO. 2020-291

A RESOLUTION APPROVING THE CONTRACT WITH JOHN HUDSON, FOR PROVISION OF AS-NEEDED TENNIS PRO SERVICES AT THE FLORIDA TENNIS CENTER FOR A ONE-YEAR TERM COMMENCING OCTOBER 1, 2020, WITH TWO ONE-YEAR RENEWAL OPTIONS; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONTRACT; APPROVING THE EXPENDITURE IN AMOUNT OF \$82,000 TO PAY MR. HUDSON FOR SERVICES PROVIDED DURING THE FIRST CONTRACT YEAR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE RENEWAL OPTIONS PROVIDED IN THE CONTRACT, AND EXPEND SUCH SUMS FOR SERVICES DURING THESE RENEWAL PERIODS AS ARE BUDGETED AND APPROPRIATED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 30-57(a)(2), City Code, provides procurement of personal services contract without competitive selection; and

WHEREAS, the City is in need of a tennis pro at Florida Tennis Center to provide tennis lessons, restring tennis racquets and conduct tennis tournaments on the City's behalf; and

WHEREAS, John Hudson is an experienced tennis pro and is willing to provide such services for a one-year term, with options to renew up to two additional terms of one-year each; and

WHEREAS, a proposed contract has been drafted outlining terms and conditions; and

WHEREAS, pursuant to the proposed contract, the City would pay Mr. Hudson \$14.00 for each racquet restrung, and 80% of the fees collected by the City for group lessons taught by Mr. Hudson on the City's behalf; and

WHEREAS, additionally under the proposed contract, Mr. Hudson would be authorized to provide private tennis lessons and hold private tennis tournaments at the Florida Tennis Center subject to terms and conditions, including Mr. Hudson's payment to the City of a monthly fee of \$600.00; and

WHEREAS, the Business Enterprise Management Director estimates that the gross revenue stream to be received by the City on account of the proposed contract, will be \$127,000 annually, and the Director recommends that the City Commission approve the contract; and

WHEREAS, the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The Tennis Pro Contract with John Hudson for provision of tennis pro services at the Florida Tennis Center for a one-year term commencing October 1, 2020 with two one-year renewal options, as further described above, is hereby accepted.

SECTION 2. The Mayor and City Clerk are hereby authorized to execute the above-referenced Contract, a copy of which is attached hereto and made a part hereof in substantially final form.

SECTION 3. The expenditure of an amount not to exceed \$82,000, for Mr. Hudson's provision of tennis pro services during the first year of the Contract, is hereby approved.

SECTION 4. The City Manager is hereby authorized to exercise the City's option to exercise the City's options to renew the Contract as referenced above, and to make expenditures for services during the option periods, subject to budgeting and appropriation.

SECTION 5. This Resolution shall take effect immediately upon its adoption.
