AGREEMENT NO. 16-151-RFP-2 AMENDMENT NUMBER 2

This Amendment Number 2 is made on the date of execution by the County and amends Agreement Number 16-151-RFP-2 dated December 17, 2018 ("Main Agreement") between Home Care Partners, Inc 1234 Massachusetts Ave NW, Suite C1002, Washington, DC 20005 ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor amend the Scope of Work called for under the Main Agreement as follows:

6. REFERRAL, EVALUATION, AND ADMISSION PROCESS (P.26):

Add:

14. If the assigned aide goes to the client's home to provide scheduled services and the client is not present or refuses services, the Contractor may bill the County for up to one hour of service at the contracted rate and pay the aide for one hour of work. The Contractor will immediately contact the County Project Officer or designee who will follow-up with the client. Clients who are not present or turn aides away more than twice will be terminated from county services. There will be exceptions for clients with cognitive impairment such as dementia; those exceptions will be decided on a case-by case basis.

It is the Contractor's responsibility to communicate the cancellation process to their assigned clients, upon admission and during routine contacts with clients. This includes a 24-hour notice the client must give the Contractor for canceling scheduled services.

All other terms and conditions of the Main Agreement remain in effect.
