The County and the Contractor agree to amend the Main Agreement as follows:


REVISE THE CONTRACT TERM PARAGRAPH 2 AS FOLLOWS:

The new contract term will start on July 1, 2021 and work is to be completed by June 30 ,2022 or until a new Regional agreement is in place, whichever occurs first.


All other terms and conditions of the Main Agreement, as amended shall remain in full force and effect.
