**AMENDMENT NUMBER 1  
ASSIGNMENT OF AGREEMENT**

This Amendment Number 1 ("Amendment") is made on 6/27/2022 by the County and amends Agreement Number 22-DES-ITBLW-564 ("Main Agreement") between ZWE Logistics, LLC, 12343 Carroll Avenue, Rockville, Maryland 20852 ("Contractor"), and the County Board of Arlington County, Virginia ("County").

ZWE Logistics, LLC, and the County entered into the Main Agreement for ZWE Logistics, LLC, to provide *Source Separated Organics (SSO) collection and composting service for Arlington County facilities*.

Compost Crew, Inc, A Benefits Corporation, 12343 Carroll Avenue, Rockville, Maryland 20852 has assumed all of ZWE Logistics, LLC's rights, and obligations in the Main Agreement. The work and payment called for under this amendment shall be subject to all terms and conditions of the Main Agreement unless specifically changed by the terms and conditions of an additional amendment.

The County consents to the assignment of the Main Agreement to Compost Crew, Inc beginning on January 3, 2023 ("Effective Date").

The Main Agreement is therefore amended as follows:

1. ZWE Logistics, LLC, is in all instances replaced with Compost Crew, Inc.
2. The term "Contractor" in the Main Agreement means Compost Crew, Inc.
