AGREEMENT NO. 20-266-R-1  
AMENDMENT NUMBER 1

This Amendment Number 1 is made on July 17, 2020 by the County and amends Agreement Number 20-266-R-1 ("Main Agreement") dated May 27, 2020 between Godwin Manufacturing Co., Inc. ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

**1. AMEND PARAGRAPH 2 CONTRACT TERM AS FOLLOWS:**

Remove "There are no renewal options available" and replace with the following language:

"Upon satisfactory performance by the Contractor, if the Virginia Sheriffs Association renews their agreement identified in Exhibit A, the County may elect to renew this Agreement under the same contract terms for two (2) one-year renewal periods from August 15, 2020 to August 14, 2022 ("Subsequent Contract Term"). However, if the Virginia Sheriffs Association does NOT renew their agreement identified in Exhibit A, this Agreement shall automatically expire on the date of the contract expiration date."

All other terms and conditions of the Main Agreement remain in effect.
