AMENDMENT NUMBER 3

This Amendment Number 3 ("Amendment") is made on the date of execution of this Amendment by the County and amends Arlington County Agreement Number 66-11, dated April 20, 2009 ("Agreement as Amended"), and made between Aramark Correctional Services, LLC., 1101 Market Street, Philadelphia, PA 19107 ("Contractor"), a Delaware Limited Liability Company authorized to transact business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Work called for and amounts to be paid under the Agreement, as Amended, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Agreement as follows:

I. Replace Section 4 ("Contract Term") of the Agreement in its entirety with the following:

**CONTRACT TERM**

Work under this Agreement will commence upon execution of this Agreement by the County and shall be completed no later than March 31, 2018 ("Contract Term"), subject to any modifications as provided for in the Contract Documents.

Upon Satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may, through issuance of an amendment executed by the parties, authorize continued operations of the Contractor under the same contract prices for not more than one (1) additional twelve (12) month periods from April 1, 2018 to March 31, 2019 (each such period shall be referred to as "Subsequent Contract Term").

II. Amend EXHIBIT B ("Pricing") of the Agreement in accordance with the attached revised EXHIBIT B:

Pricing for this renewal term reflects a 2.5% increase over the prior Subsequent Contract Term and in accordance with the U.S. Department of Labor, Consumer Price Index, All Items, Unadjusted, Urban Areas ("CPI-U") for the twelve (12) month period ending in January, 2017.

All other terms and conditions of the Agreement, as Amended, shall remain in full force and effect.
