ARLINGTON COUNTY, VIRGINIA AGREEMENT NO. 19-311-ITB AMENDMENT NUMBER 1

This **Amendment Number 1** is made on the date of execution by the County and amends **Agreement Number 19-311-ITB** ("Main Agreement") dated **June 26, 2014** between **Wireless Communications, Inc.** ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the Main Agreement as follows:

1. ADD CLAUSE #55 TO THE CONTRACT AS FOLLOWS:

55. COVID-19 VACCINATION POLICY FOR CONTRACTORS

Due to the ongoing COVID-19 pandemic, the County has taken various steps to protect the welfare, health, safety, and comfort of the workforce and public at large. As part of these steps, the County has implemented various requirements with respect to health and safety including policies with respect to social distancing, the use of face-coverings and vaccine mandates. To protect the County's workforce and the public at large, all employees and subcontractors of the Contractor who are assigned to this Contract, must be fully vaccinated against COVID-19. Any contractor employee or subcontractor who is not fully vaccinated should be following a weekly testing protocol as established by the Contractor.

- 2. REVISE SPECIFICATIONS, SECTION C. SERVICES TO BE PROVIDED, PARAGRAPH 3. SECTION 3- OTHER SERVICES, ITEM d. TO READ AS FOLLOWS:
 - d. For any additional service, the Contractor shall provide a written estimate to the requesting Office/Department, except in case of emergency, and get the Requesting Office/Department's approval before commencing work. The County shall have the option to purchase the needed parts or ask the Contractor to do so on a time a materials basis quoted prior to service.
- 3. REMOVE PARAGRAPH 4. SECTION 4 PARTS AND ACCESSORIES FROM SPECIFICATIONS, SECTION C. SERVICES TO BE PROVIDED IN ITS ENTIRETY.
- 4. REPLACE ATTACHMENT B PRICING SCHEDULE, SECTION 1: PUBLIC SAFETY PREVENTIVE MAINTENANCE AND REPAIR SERVICE WITH THE FOLLOWING:
