

RESOLUTION NO. 18-102

A RESOLUTION ACCEPTING THE LOW BID OF FAM PRESSURE CLEANING, LLC, TO PROVIDE PRESSURE WASHING AS-NEEDED AT VARIOUS CITY FACILITIES FOR A TERM OF THREE YEARS, WITH OPTIONS TO RENEW FOR TWO ONE-YEAR TERMS, AT A TOTAL COST NOT TO EXCEED \$71,388.38 ANNUALLY; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONTRACT WITH FAM PRESSURE CLEANING, LLC, CORRESPONDING TO THE BID DOCUMENTS; AUTHORIZING THE CITY MANAGER TO EXERCISE THE CITY'S OPTIONS TO RENEW, SUBJECT TO BUDGETING AND APPROPRIATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, bids for pressure washing services as needed at various City facilities, were duly called for and advertised; and

WHEREAS, all bids received were opened on January 11, 2018, and are listed on the Bid Tabulation attached hereto and made a part hereof; and

WHEREAS, the Deputy Public Works Director recommends acceptance of the bid submitted by FAM Pressure Cleaning, LLC, and the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission finds that the lowest and best bid submitted by a responsive bidder is the following:


SECTION 4. The Chief Financial Officer is hereby authorized to return the bid security of all unsuccessful bidders in accordance with the terms of the bid documents.
